Taught together with a number of partner universities in countries such as France, Great Britain, Spain, Brazil and Argentina, the HWR Berlin enables its students to achieve both a German Bachelor's degree in Business Administration and a degree from the partner institution.

Study for a global future: the fifth and sixth semester of this degree programme is spent at the partner university of the student's choice. The compulsory internship semester is also completed abroad or within an international company.
